Feedback Requested - Dave Johnson, Planning Commission Chair

The Planning Commission has been working on a couple of projects that could use some input from you, the residents of the Township. Also we have an issue that is new to the Township that we will be discussing in the future that also could use some input from you.

First issue is related to an ongoing process of reviewing the Comprehensive Plan and how it reflects on our recommendations we make to the Cass County Planning and Zoning on variances requested by property owners. Typically most variances have been granted with some conditions. Our Comprehensive Plan speaks overwhelmingly to protection of water quality and green space within the Township. We have a sense that we are not being true to the intent of the Comp Plan if these variances are granted too easily. So the question to you is: would you prefer a more strict interpretation of the Comp Plan making these variances more difficult to grant? Secondly a topic that has not been discussed by the Planning Commission is that of rentals through Vacation Rentals By Owner (VRBO). These rentals are becoming more popular in the lakes area and there is currently very little regulation regarding numbers, age, length of rentals, hours, etc. What are your thoughts regarding regulation of this type of rental.

Dark Skies - Vickie Kettlewell

The Sylvan Township Planning Commission is initiating a "Dark Skies" project. This initiative seeks to encourage citizen participation in preserving one of the assets of living in this township – dark skies and starry nights. The initiative is strictly voluntary and seeks to offer sources to Sylvan residents who want to make the change in their lighting. We want to offer information about light pollution, resources and information on how to mitigate outdoor lighting so as to not send out light drift, and economic solutions to lighting design that reduces light pollution, which can include not lighting at all. We are promoting this initiative by recognizing home owners or business owners who decide to make changes. The Township would like to recognize these efforts with both a medallion they can display on their dwelling, and a "how I did this" article in the Township newsletter. Sharing information can be very helpful to others. Through "how to" stories, making resources available and giving recognition to good lighting design, not only does the effort have potential to build community, we all have a good chance to look up and see the stars. We are proposing starting this initiative mid-fall.

Sylvan Township: Starry, Starry Nights Initiative

Dear neighbors and residents of Sylvan Township,

We can tick off a dozen reasons we live in this northern township – lakes, the pines, wildlife, rural character, and likely the night sky. Humans have gazed at the stars for thousands of years. They have found inspiration, wonderment, cultural lore and inspiration. And, they found their way – navigating by the location of the stars.

Sylvan Township would like to engage its citizens in an effort to preserve our night skies. Stargazers across the globe are increasingly concerned by the loss of darkness to light pollution. Not only does light pollution decrease our ability to see the spectrum of stars across the sky, but it also interrupts natural cycles. Our own circadian rhythm needs darkness for our sleep cycle.

What is light pollution? In its most obvious forms it is the artificial light that accumulates and begins to diminish the dark sky, so to the human eye we often see a glow of light on the horizon, or we can't see many stars when looking up, or it feels like twilight and is never really dark out.

Why does that matter? At a human scale, it can be disruptive to our sleep, to our health. For wildlife, it can disrupt mating, migration, navigation ability and predator-prey behaviors. Darkness is important.

What can you do? Today, there are many options to nighttime lighting that are smart, efficient and can help keep our skies dark and lighting where it is needed. Not only has lighting design changed so that it can be very direct and downward, not aimed at the sky, but it is highly efficient and cost effective, especially with LED technology.

Sylvan Township is interested in keeping its skies dark and would like to ask residents to look up and see the stars. We also want to encourage home and business owners to consider their own light needs and whether their lights might be adding to light pollution.

As an added incentive to giving consideration to your lighting needs, we want to recognize residents who decide their lighting could be changed or adjusted to help keep our dark skies. If you are interested in participating and decide to make changes, let us know. Tell us your story, what changes you made. We would like to recognize residents who make changes with a certificate and mention in the Township's newsletter.

In the near future, Sylvan would like to invite its residents to a stargazing evening at its Park on Sylvan Lake. We plan to invite some amateur astronomers and have an evening of discovering the stars.

Roads - John Wulff Co Road Supervisor

Sylvan Township has many levels of roadways in its borders, some are maintained by the Township and some cannot be maintained with Township funds. In the next few paragraphs we will look at why some roads are maintained and what could change the status of a road.

Most of us travel many different roads every day. These vary from our driveway to large interstate highways. There is a state highway and three county roads that are in or pass through Sylvan Township. Since this is the Township newsletter we will focus on Township and public roads in Sylvan Township. Sylvan Township has about 60 miles of recorded Township roads with about 50 miles that are paved and 10 miles that are not paved. If one looks at a web map such as Google Maps or Bing Maps there are many additional roads that are used by the public that are named and have street signs. The difference is that these additional roads have not been accepted as a Township road and do not have a road order that is recorded by the Township with the Cass County Recorder office.

Several years ago as the Enhanced 911 addressing system was implemented and the blue number signs were installed, most of unnamed roads were named and street signs were installed by Cass County. Prior to this time usually only the Township roads were named and had street signs. With the roads having both street signs and address numbers how does one know if the road in question is a township road or a public road?

In the late 80's and early 90's Sylvan Township went through a process to document and register the Township roads with Cass County. If you have a question about the status of a road a call to Sylvan Township will verify the status. In short a "Town road" is defined as: those roads and cartways which have heretofore been or... may be established, constructed or improved ... [by] Town boards; and roads established, constructed, or improved by counties and have been maintained by the towns for a period of at least one year prior to July 1, 1957. This is from Minn. Stat. 160.02, subd. 28.

The question "Can a road become a Township road"? is often asked. Yes it can through processes established by the State of Minnesota. If a request is made for the Township to accept a road as a Township road the Board will work with the residents to see that the road meets the specifications and the steps to accept the road.
