Public Hearing Meeting Minutes – United Welding (Kim Meyer) Thursday July 15th, 2021

Call to Order/Pledge of Allegiance/Roll Call: Chair Booth called the Public Hearing Meeting to order at 6:56 pm and the Pledge of Allegiance was said at the previous Public Hearing. Those present at the meeting were Supervisors Greg Booth, Arlene Schmit, Yvette Adelman-Dullinger, Greg Bennett, Bob Johnson, and Clerk Jenna Ruggles. Residents present included Kim Meyer, Les McClelland, Dave Johnson, and Dave Skogen.

Purpose of Hearing is to discuss and take comments on the application for an Interim Use Permit (IUP) for Kim Meyer - United Welding to conduct business at his residence.

Supervisor Booth read the Public Notice and Clerk Ruggles entered it into the record of proceeding. Supervisor Booth announced that the Affidavit of Publication was in the Brainerd Dispatch on July 4th, 2021 and Clerk Ruggles entered it into the record.

Supervisor Booth welcomed the public then allowed Mr. Meyer time to explain his permit application. After Supervisor Booth opened it up for comments from the public.

Discussion included the following questions and concerns.

- They have Argon gases in their shop and trucks, so developing a plan and letting the Pillager Area Fire and Rescue know was recommended.
- The only materials coming back to the shop are sections of scrap for testing purposes, no hazardous materials.
- Only welding performed on-site would be to test a new employee on a piece of scrap.

Supervisor Bennett **moved to approve the Interim Use Permit Application for Kim Meyer-United Welding with Conditions that the business will develop a Safety Plan for the Argon gasses and share that plan with the Pillager Area Fire and Rescue the business will meet all other county, state, and federal regulations**, seconded by Supervisor Adelman-Dullinger. The conditions are listed below.

Adjournment: Supervisor Schmit **moved to adjourn**, seconded by Supervisor Bennett and the motion carried with the meeting adjourning at 7:10 pm.
