Call to Order/Pledge of Allegiance/Roll Call: Chair Booth called the Board of Supervisors Meeting to order at 6:30 pm and the Pledge of Allegiance was said. Those present at the meeting were Supervisors Greg Booth, Keith Card, Bob Johnson, Greg Bennett, Arlene Schmit, and Clerk Jenna Ruggles. No residents were present, the sign-in sheet is attached.

Agenda: Supervisor Schmit **moved to approve the agenda as presented**, seconded by Supervisor Card and the motion carried.

The Board reviewed the Receipts Register, County Funds received, Disbursement Register, Schedule 1, and Schedule 8. There were no questions on the reports.

Draft Audit results from CliftonLarsonAllen (CLA) were reviewed and discussed. Supervisor Bennett **moved to approve the Draft Audit results pending that no changes are made after the State Auditor releases the Minnesota Legal Compliance and the audit is finalized**, seconded by Supervisor Card and the motion carried.
