- Wilderness Dr (E of L Sylvan): Good
- Little Red Sand Dr: Good – but dirt ends Not Reviewed
- Hidden Lake Rd: Patch near end of turnaround
- 25th Ave: Shouldering & 2 large holes near 210 and near Wilderness
- Zebroski Acres Ln: Shouldering near turnaround
- Wilderness Dr (W of L Sylvan): Good
- W Sylvan Dr: Major work needed on road, Delineators, Gutters/Curb area needs to be cleaned up, Shouldering & holes off 210, Wilderness, and curves, Patching needed, has raised areas
- Gregory Dr (shared): Fairview maintains all
- **N 210 – 33rd & W**
- 33rd Ave/Pillsbury Forest Rd: Shouldering at 210, Delineators, SKIP low area when Crack Sealing
- 125th St (W side): Patching needed 2 spots over culverts – marked on road
- 37th Ave: Good, no Calcium Chloride this year
- 43rd Ave: Shouldering needed near Spring Rd and Sign needed at end
- Beaver Dam Rd (mm): Brushing needed and Sign by 1st culvert on S side put back in
- Spring Rd: Good

Discussions after returning included the above recap and that overall, the roads look to be in good shape. We will crack seal all roads on the North side of Hwy 210 this year and include Prairiewood and Prairie Star Cir from the South side. We will have our Road Committee look at 33rd Ave, W Sylvan, and W Lake Ridge roads to give us an idea of what we should do or where to add them into our 5-year plan. Clerk Ruggles will ask Anderson Brothers for an estimate on 120th St and then share it with East Gull Lake to see if they would like to have the work done.
