Jacob's orbit took in many of us. His song is a great song. Help be a caring part of our community. Be kind.

PNP Election

(Presidential Nominating Primary)

March 5th, 2024





Will all political parties be participating in the PNP Election?

No, only the 3 major parties will be participating - Democratic-Farmer-Labor, Legalize Marijuana Now, and the Republican parties. Each party will have it's candidates for President only on the ballot, you will choose one candidate.

Will there be any other offices on the ballot besides President?

No, this is only the Presidential Nominating Primary Election.

Will all parties be on the same ballot?

No, you will need to disclose your political party to the election judge prior to voting. If you choose to not disclose your political party, you will NOT be able to vote in the PNP Election.

Will other people know which party or candidate that I vote for?

A voter's choice of party ballot will be recorded and is private data. However, a list will be provided to the chair of each major political party of voters who selected that party, the candidate you choose will be a secret. Election judges are trained to be discrete and take an oath to protect your privacy as a voter.

Who can vote in the PNP Election?

Any voter registered to vote can vote at the PNP Election on March 5th, 2024. Any non-registered voter can also register and vote for the PNP Election on March 5th, 2024.

Who decides what candidates will appear on a party's ballot?

The chair of each party have submitted a list of candidates for the party's ballot on or before January 2, 2024 to be on the ballot.

What if a candidate drops out before the PNP Election?

Once the political party chair submits their list of candidates to appear on the ballot (January 2, 2024), no changes will be made to that party's candidates on the ballot.

Will there be a place to write-in a choice or vote for "uncommitted"?

Only if it is requested by the chair of that political party.

Will there still be precinct caucuses?

Yes, precinct caucuses and local and state nominating conventions will still take place to conduct other party business.

What if I cannot make it to my polling place on March 5th, 2024 to vote?

Absentee Voting is currently open at Sylvan Town Hall for Sylvan residents. You can vote absentee prior to March 5th if you wish.



Road Reports

Sylvan Township has a new Road Contractor, Ryan Bodell, Bodell Landscape & Excavation LLC. Ryan and his family have lived in the area for 25 years and Ryan has 11+ years of experience. We are very excited to have Ryan and his team working for Sylvan Township. They have been doing a fantastic job so if you see him or his team out on the roads, feel free to give them a wave or say hello. - Arlene Schmit, Road Supervisor

Sylvan Township had a busy year in 2023. Two more roads that are in our township boundaries have now become fully maintained township roads. Residents from both 135th and Acorn Drive completed the process of requesting that the township take over maintenance. This process included a petition to the board, bringing roads up to township standard and agreeing to easements where needed. Our new contractor, Ryan Bodell and his crew did a great job bringing the roads up to standard allowing the board to finalize both as township roads.

Other major projects that were completed in 2023 are the overlay on Little Pine and 3 roads in the Bigwater area (Ace Dr, Crow Wing Cir, & Golf Course Cir). Anderson Brothers was the contractor on both projects and did a fantastic job.

Our road committee consisting of experts in road construction and maintenance once again updated the 5-year plan for maintenance of all roads classified as township

roads. They have identified possible future fixes that will be needed for continual safe standards around the township. General maintenance this past year included mowing of ditches, crack sealing, shouldering where needed, cut and patch of road hazards that were identified as immediate fixes and general brushing.

Just a reminder that when we have early snowfall before the cold weather hits, we are limited on plowing gravel roads. Gravel roads are often soft at first snow and our plows and equipment can do extensive damage to the roads. We will make every effort to provide snow plowing to all roads as the strength of the roads permit.

Unfortunately, 2023 was not the greatest year for Sylvan Park. Drought, weeds, and downed trees along with a lack of leadership on my part resulted in less progress than we should have

experienced. That was 2023... this is 2024 and things will be different!

We had a fired-up group of park committee members at the January 6th meeting. Items discussed and agreed upon include:

- * Adding a kiosk that will give information on the park and the trail system
- * Replacing the current sign at the entrance
- * Planting an additional 50 trees
- * Hosting an open house, likely in the summer
- * Hosting a star gazing event
- * Burning a few brush piles this winter if our snow does not melt
- * Conducting a prescribed burn on a 10-acre portion of the park as part of our forest management plan
- Conducting a series of weeding efforts in the wildflower area to we called "weed of the week"
- * Many more possibilities were discussed
